We have audited, in accordance with *Government Auditing Standards* issued by the Comptroller General of the United States, the basic financial statements of the City of Wapakoneta for the year ended December 31, 2023, and have separately issued our unmodified report thereon dated September 12, 2025. These statements present the landfill as part of the Refuse fund, a major enterprise fund and also within the City of Wapakoneta's business-type activities.

In a letter to the Ohio Environmental Protection Agency dated October 6, 2025 (the Letter), the City Auditor the City of Wapakoneta specified that certain amounts disclosed in that Letter were derived from the independently audited financial statements referred to in the first paragraph above.

We have performed the procedures described below on the City of Wapakoneta. The City of Wapakoneta's management is responsible for the information presented in the Letter.

The City of Wapakoneta has agreed to and acknowledged that the procedures performed are appropriate to meet the intended purpose of solely providing assistance to you in determining that certain amounts reported in the Letter agreed to, or can be computed from, amounts presented in the audited basic financial statements. Additionally, the Auditor of State has agreed to and acknowledged that the procedures performed are appropriate to meet their purposes. This report may not be suitable for any other purpose. The sufficiency of the procedures is solely the responsibility of the parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

As required by Ohio Admin. Code 3745-27-15(L)(5)(c) and 3745-27-16(L)(5)(c), we have agreed the following amounts included in the Letter to the audited financial statements:

Alternative 2, Line No.  
5 Total assured environmental costs  
6 Total annual revenue

The amounts on line 6 agree to the basic fund financial statements of the City of Wapakoneta, or can be computed from amounts appearing therein. We followed the definition for line 6 included in the *State Support Document for the Local Government Financial Test*, issued November 27, 1996 by the USEPA. Line 5 includes total assured environmental costs reported in the fund financial statements following Governmental Accounting Statement Number 18.
