INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

We have audited, in accordance with *Government Auditing Standards* issued by the Comptroller General of the United States, the basic financial statements of the City of Avon Lake for the year ended December 31, 2007, and have separately issued our unqualified report thereon dated December 12, 2008.

The amounts on line 6 agree to the basic financial statements of the City of Avon Lake, or can be computed from amounts appear therein.
