INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

SRWW #2 Joint Fire District Clinton County 179 S. Jackson Street Sabina, Ohio 45169

We have performed the procedures enumerated below, with which the Board of Trustees and the management of SRWW #2 Joint Fire District, Clinton County, Ohio (the District), agreed, solely to assist the Board in evaluating receipts, disbursements and balances recorded in their cash-basis accounting records for the years ended December 31, 2009 and 2008, and certain compliance requirements related to these transactions and balances. Management is responsible for recording transactions; and management and the Board are responsible for complying with the compliance requirements. This agreed-upon procedures engagement was conducted in accordance with the American Institute of Certified Public Accountants' attestation standards and applicable attestation engagement standards included in the Comptroller General of the United States' Government Auditing Standards. The sufficiency of the procedures is solely the responsibility of the parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

This report only describes exceptions exceeding \$10.

Cash and Investments

- 1. We tested the mathematical accuracy of the December 31, 2009 and December 31, 2008 bank reconciliations. We found no exceptions.
- 2. We agreed the January 1, 2008 beginning fund balances recorded in the Cash Journal and Annual Financial Report to the December 31, 2007 balances in the prior year audited statements. We noted that the beginning fund balance as reported in the cash journal did not agree to the prior year audited statements. This was due to a prior year audit adjustment posted by the fiscal officer on November 5, 2008.
- We agreed the totals per the bank reconciliations to the total of the December 31, 2009 and 2008 fund cash balances reported in the Cash Journal and Annual Financial Reports. The amounts agreed.
- 4. We confirmed the December 31, 2009 bank account balances with the District's financial institutions. We found no exceptions.
- 5. We tested all outstanding checks from the December 31, 2009 bank reconciliation:
 - a. We traced two checks to the debit appearing in the subsequent January bank statement. Two stale-dated checks were outstanding as of March 31, 2010. We recommend the District cancel & reissue stale dated checks that are greater than six months old.

- b. We traced the amounts and date written to the cash journal, to determine the checks were dated prior to December 31. We noted no exceptions.
- 6. We tested investments held at December 31, 2009 and December 31, 2008 to determine that they:
 - Were of a type authorized by Ohio Rev. Code Sections 135.13, 135.14 or 135.144. We found no exceptions.
 - b. Mature within the prescribed time limits noted in Ohio Rev. Code Section 135.13 or 135.14. We noted no exceptions.

Property Taxes, Intergovernmental and Other Confirmable Cash Receipts

- 1. We selected a property tax receipt from one *Statement of Semiannual Apportionment of Taxes* (the Statement) for 2009 and one from 2008.
 - a. We traced the gross receipts from the *Statement* to the amount recorded in the Receipts Ledger. The amounts agreed.
 - b. We determined whether the receipt was allocated to the proper funds as required by Ohio Rev. Code Sections 5705.05-.06 and 5705.10. We found no exceptions.
 - c. We determined whether the receipt was recorded in the proper year. The receipt was recorded in the proper year.
- 2. We scanned the Receipts Ledger to determine whether it included the proper number of tax receipts for 2009 and 2008:
 - a. Two personal property tax receipts
 - b. Two real estate tax receipts

We noted the Receipts Ledger included the proper number of tax settlement receipts for each year.

- We selected five receipts from the State Distribution Transaction Lists (DTL) from 2009 and five from 2008.
 - a. We compared the amount from the DTL to the amount recorded in the Receipts Ledger. The amounts agreed.
 - b. We determined whether these receipts were allocated to the proper account code(s). We noted that a State Training Grant in the amount of \$5,500 was posted to the Miscellaneous line item instead of the Intergovernmental line item.
 - c. We determined whether the receipts were recorded in the proper year. We found no exceptions.

Ambulance Receipts from Billing Organization

1. We confirmed amounts paid from the Ambulance and Emergency Medical Services (AEMS) - Transports to the District during 2008 and 2009. We found no exceptions.

- a. We determined whether these receipts were allocated to the proper account codes. We found no exceptions.
- b. We determined whether the receipts were recorded in the proper year. We found no exceptions.
- We confirmed amounts paid from the Federal Emergency Management Agency during 2009. We noted that that during 2009 a grant for \$53,865 from the Federal Emergency Management Agency (FEMA) was posted as a Miscellaneous Receipt to the Ambulance and Emergency Medical Service Fund (AEMS) Fund instead posting an Intergovernmental Receipt in the FEMA Fund as prescribed by Auditor of State Bulletin 1998-013.

Debt

- We inquired of management, and scanned the Receipt Ledger and Appropriation Ledger for evidence of bonded or note debt issued during 2009 or 2008 or outstanding as of December 31, 2009 or 2008. We noted no new debt issuances and all debt noted agreed to the summary we used in step 2. We found no exceptions.
- 2. We obtained a summary of note debt activity for 2009 and 2008 and agreed principal and interest payments from the related debt amortization schedule(s) to the General Fund and AEMS Fund payments reported in the Appropriations Ledger. We also compared the date the debt service payments were due to the date the District made the payments. We found no exceptions.

Payroll Cash Disbursements

- We haphazardly selected one payroll check for five employees from 2009 and one payroll check for five employees from 2008 from the Payroll Records Journal and determined whether the following information in the minute record was consistent with the information used to compute gross and net pay related to this check:
 - a. Name
 - b. Authorized salary or pay rate
 - c. Retirement system participation and payroll withholding.
 - d. Federal, State & Local income tax withholding authorization and withholding.
 - e. Any other deduction authorizations (deferred compensation, etc.)

We found no exceptions related to steps a. -f. above.

- 2. We tested the checks we selected in step 1, as follows:
 - a. We compared the hours and pay rate, or salary amount used in computing gross pay to supporting documentation (timecard or legislatively-approved rate or salary). We found no exceptions.
 - b. We recomputed gross and net pay and agreed it to the amount recorded in the payroll register. We found no exceptions.

3. We scanned the last remittance of tax and retirement withholdings for the year ended December 31, 2009 to determine whether remittances were timely paid, and that the amounts paid agreed to the amounts withheld during the final withholding period during 2009. We noted the following:

Non-Payroll Cash Disbursements

- 1. For the Appropriation Ledger report, we refooted checks recorded as disbursements for the General Supplies fund for December of 2008 and 2009. We found no exceptions.
- We agreed total disbursements (non-payroll and payroll) from the Year End Financial Report for the years ended December 31, 2009 and 2008 to the total disbursements recorded in the check register. We found no exceptions.
- 3. We haphazardly selected ten disbursements from the Cash Journal for the year ended December 31, 2009 and ten from the year ended 2008 and determined whether:
 - a. The disbursements were for a proper public purpose. We found no exceptions.
 - b. The check number, date, payee name and amount recorded on the returned, canceled check agreed to the check number, date, payee name and amount recorded in the Cash Journal and to the names and amounts on the supporting invoices. We found no exceptions.
 - c. The fiscal officer certified disbursements requiring certification or issued a *Then and Now Certificate*, as required by Ohio Rev. Code Section 5705.41(D). We found no exceptions.
 - d. The payment was posted to a fund consistent with the restricted purpose for which the fund's cash can be used. We found no exceptions.

Compliance - Budgetary

- 1. We compared the total from the *Amended Official Certificate of Estimated Resources* required by Ohio Rev. Code Section 5705.36(A)(1), to the amounts recorded in the Appropriation Ledger for the General Fund, Ambulance Emergency Medical Services (AEMS) and Fire Trust Funds for the years ended December 31, 2009 and 2008. The amounts agreed.
- 2. We scanned the appropriation measures adopted for 2009 and 2008 to determine whether, for the General, AEMS and Fire Trust funds, the Trustees appropriated separately for "each office, department, and division, and within each, the amount appropriated for personal services," as is required by Ohio Rev. Code Section 5705.38(C). We found no exceptions.

- 3. We compared total appropriations required by Ohio Rev. Code Sections 5705.38 and 5705.40, to the amounts recorded in the Appropriation Ledger for 2009 and 2008 for the following funds: General, AEMS and Fire Trust Funds. The amounts on the appropriation resolutions agreed to the amounts recorded in the Appropriation Ledger report.
- 4. Ohio Rev. Code Section 5705.39 prohibits appropriations from exceeding the certified resources. We compared total appropriations to total certified resources for the General, AEMS and Fire Trust Funds for the years ended December 31, 2009 and 2008. We noted no funds for which appropriations exceeded certified resources.
- 5. Ohio Rev. Code Section 5705.41(B) prohibit expenditures (disbursements plus certified commitments) from exceeding appropriations. We compared total expenditures to total appropriations for the years ended December 31, 2009 and 2008 for the General, AEMS and Fire Trust funds, as recorded in the Annual Appropriations. We noted that expenditures did not exceed appropriations.
- 6. We scanned the 2009 and 2008 Appropriation Ledgers for evidence of interfund transfers which Ohio Rev. Code Sections 5705.14 -- .16 restrict. We found no evidence of transfers these Sections prohibit, or for which Section 5705.16 would require approval by the Tax Commissioner and Court of Common Pleas.
- 7. We inquired of management and scanned the Annual Appropriations to determine whether the District elected to establish reserve accounts permitted by Ohio Rev. Code Section 5705.13. We noted the District did not establish these reserves.

Compliance – Contracts & Expenditures

1. We inquired of management and scanned the Cash Journal report for the years ended December 31, 2009 and 2008 for procurements requiring competitive bidding under the following statutes:

Ohio Rev. Code Sections 505.37 to 505.42 & 731.14 require a fire district to competitively bid purchases of fire apparatus, mechanical resuscitators, other fire equipment, appliances, materials, fire hydrants, buildings, or fire-alarm communications equipment or service costs exceeding \$25,000.

We identified no purchases subject to the aforementioned bidding requirements.

No response was received from the officials.

We were not engaged to, and did not conduct an examination, the objective of which would be the expression of an opinion on the District's receipts, disbursements, balances and compliance with certain laws and regulations. Accordingly, we do not express an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

This report is intended solely for the information and use of management and those charged with governance and is not intended to be, and should not be used by anyone other than these specified parties.
