## INDEPENDENT ACCOUNTANT'S REPORT

We have examined Continental Local School District, Putnam County, Ohio management's assertion that the census data and pensionable wages reported to the State Teachers Retirement System of Ohio as of June 30, 2018, and for the year then ended was accurate and complete.

Management asserts that:

- The census data provided to the State Teachers Retirement System of Ohio as of June 30, 2018 is accurate and complete. Census data includes
  - First and Last Name;
  - Last four digits of the social security number;
  - Contributions remitted to the plan;
  - Pensionable Compensation.
- The census data provided to the State Teachers Retirement System of Ohio as of June 30, 2018 included all enrolled employees.
- Census data changes occurring during the year ended June 30, 2018 to an enrolled employee's eligible compensation, were properly updated with the State Teachers Retirement System of Ohio.
- All employees required to be enrolled in the State Teachers Retirement System of Ohio in accordance with statutory requirements were properly enrolled.
- The total pensionable wages and employee contributions information reported to the State Teachers Retirement System of Ohio for the year ended June 30, 2018 agrees with the payroll records of the employer.

Continental Local School District's management is responsible for the assertions. Our responsibility is to opine on management's assertions based on our examination.

We believe that the evidence we obtained is sufficient and appropriate to provide a reasonable basis for our opinion.

In our opinion, management's assertions related to the accuracy and completeness of the census data and pensionable wages as described above provided to the State Teachers Retirement System of Ohio as of and for the year ended June 30, 2018 are fairly stated in all material respects.
